INTRODUCTION • In general, all papers should begin with an introduction that includes a thesis statement (see handout on a good/bad thesis). • The purpose of the introduction is the same as any research paper: in one to two paragraphs, briefly introduce and state the issue to be examined.

The introduction of an APA-style paper is the most difficult to write. A good introduction will summarize, integrate, and critically evaluate the empirical knowledge in the relevant area(s) in a way that sets the stage for your study and why you conducted it.
